Crime Prevention Council of Lower Saxony (CPC)

- With the founding of the Crime Prevention Council of Lower Saxony (CPC) in 1995, a forum for common efforts to prevent crime and increase the citizens' feeling of security was established. The underlying philosophy was that for investigating and countering the causes of crime effectively, shared responsibilities and strategies of society as a whole were required.
- More than 250 member organisations from all relevant social sectors, among them some 200 local prevention bodies and networks, contribute with their expertise to concepts concerning public security and support their realisation.
- Supporting them and linking up their efforts is the primary task of the Crime Prevention Council of Lower Saxony and its secretariat, which is part of the Department of Justice. Several of its projects are funded in the context of a framework-partnership with the European Commission, additional support is provided by the Federal Government and foundations such as the Klosterkammer Hannover.

CPC Mission

- „It is better to prevent crime rather than to punish it.“ This quote from the Italian philosopher of law Cesare Beccaria (1738-1794) symbolizes the attitude of the Crime Prevention Council of Lower Saxony (CPC).
- With some 270 member organizations – local prevention bodies, associations, scientific institutions, government ministries and authorities – the CPC combines numerous societal groups in Lower Saxony and communicates to the public the values and concepts of a preventive approach that is based on the involvement of society as a whole.

Beccaria-standarder omfattar mått/direktiv för kvalitetssäkring och krav på kvalitet för planering, genomförande och utvärdering av brottsförebyggande program³ och projekt. De omfattar följande sju steg för ett projekts huvudsakliga arbete:

1. Problembeskrivning
2. Analys av de villkor som har förorsakat problemet
3. Fastställande av preventionsmål, projektmål samt målgrupper
4. Fastställande av åtgärder för att nå de uppsatta målen
5. Planering och genomförande av projektet
6. Analys av projektets genomförande och måluppnående (evaluering)
7. Slutsatser och dokumentering.

Background

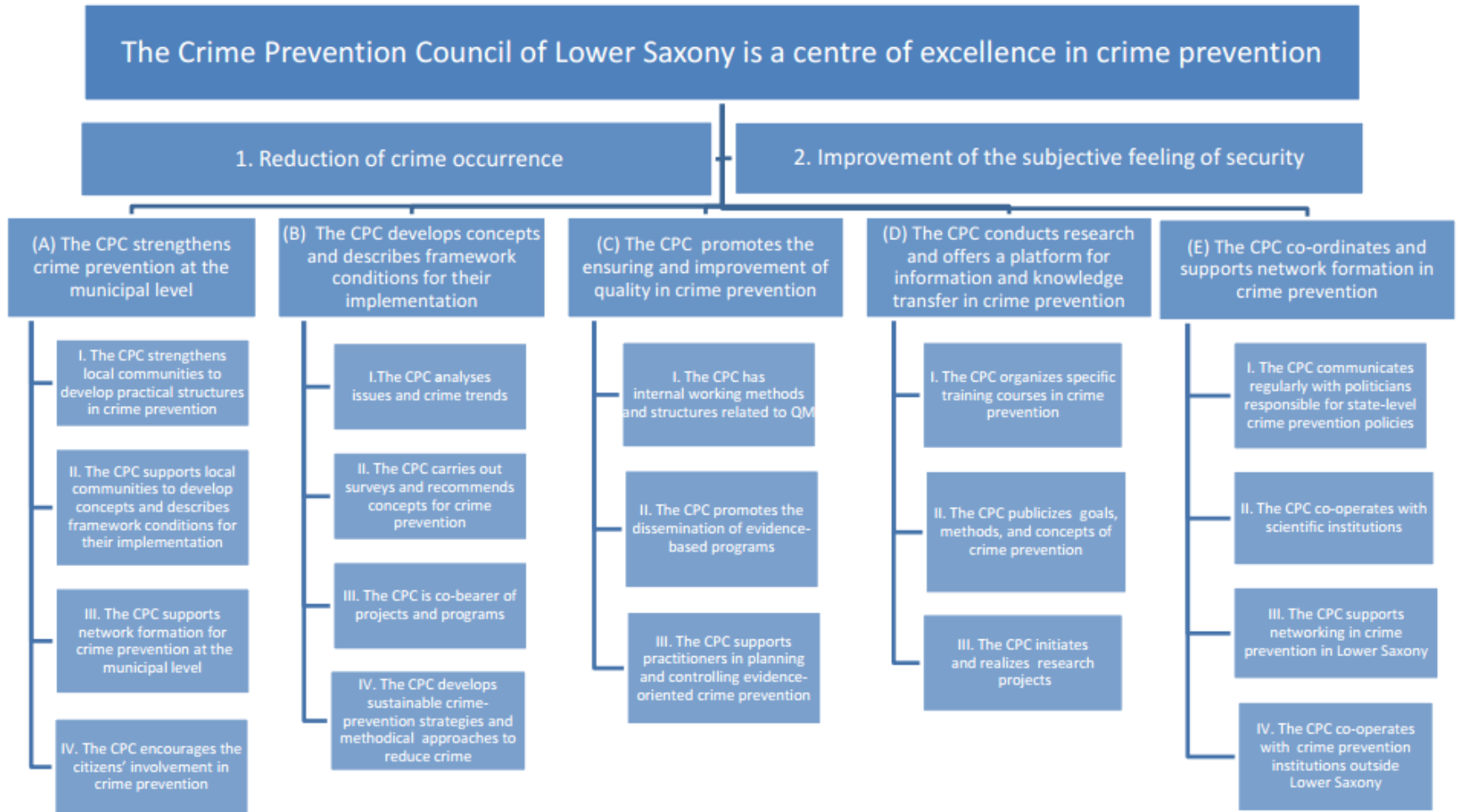
- In Germany, crime prevention is the responsibility of all three levels of government (Federal, State and Municipal).
- Due to the constitutional principle of subsidiarity, the role of non-governmental organisations and local communities has precedence over activities at the state- or federal level.
- To coordinate these efforts, crime prevention councils have been established in many municipalities and most states.
- State crime prevention councils support and advise local crime prevention bodies and networks, disseminate scientific findings and practical experience concerning crime prevention, analyse crime trends and advise the government on issues of crime policy and interdepartmental cooperation in this field.

CPC Objectives

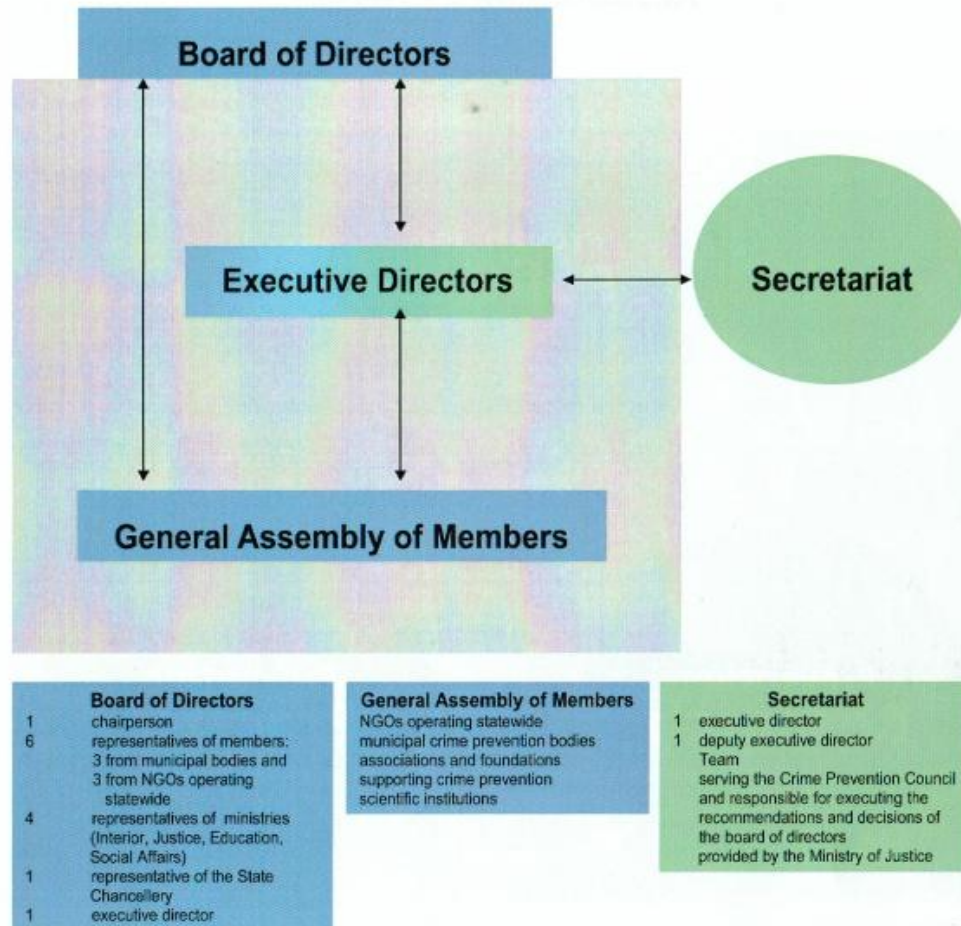
The Crime Prevention Council of Lower Saxony

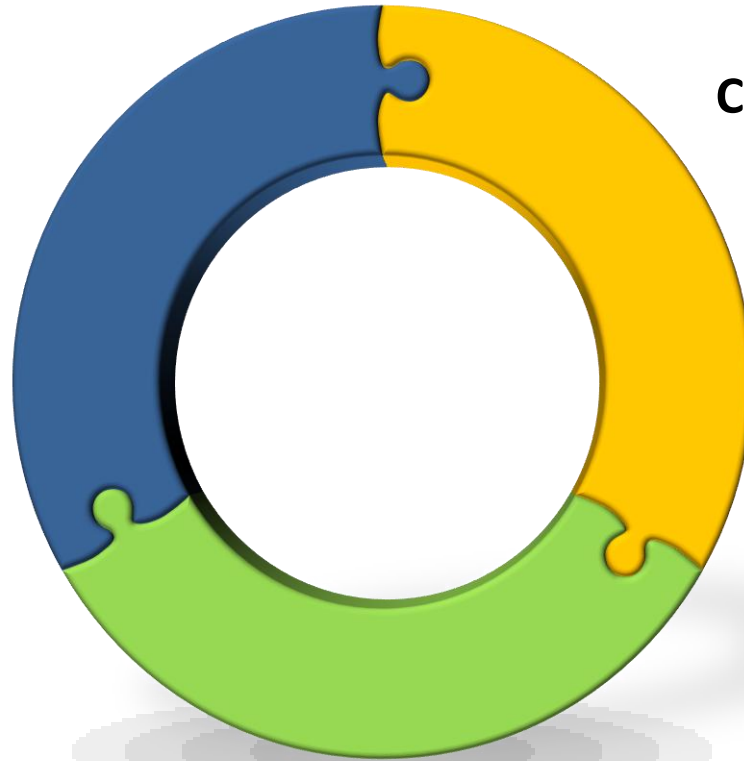
