

The ChildrenCount Surveys are a set of tools designed to paint a representative picture of the needs of all children from birth to adolescence in a given community or local authority.

The data – when aggregated up to the population-level – are designed to inform the development of investment strategies to improve child outcomes, guide the selection and implementation of evidence-based services and the design of new innovations.

The tools generate unparalleled data from approximately 600 parents of young children and up to 10,000 school-age children in a given area. These data are powerfully and dynamically visualised and considered alongside existing data on need and service use.

The ChildrenCount Surveys are an adapted version of the Evidence2Success methodology developed by the Social Research Unit at Dartington in partnership with the Annie E Casey Foundation and the Social Development Research Group.



#### Community Readiness for Change

The Community Readiness Model was developed at the Tri-Ethnic Center to assess how ready a community is to address an issue. The basic premise is that matching an intervention to a community's level of readiness is absolutely essential for success. Efforts that are too ambitious are likely to fail because community members will not be ready or able to respond. The Community Readiness Model has been used to assess readiness for a variety of issues, including drug and alcohol use, domestic and sexual violence, head injury, HIV/AIDS, suicide, parenting, animal control issues, and environmental issues.

The International Symposium on Victimology: The premier event of the Society. Held every three years in a different country, and attended by hundreds of WSV members as well as academics and professionals from a wide variety of related fields. Discussions at these events focus on the many theoretical and empirical aspects of victimology, including -- but not limited to -- victimization surveys, victim rights, victim compensation, the role of victim in offences, victimization prevention, re-victimization, assistance to victims and to service providers, psychological responses to disasters, the role of the victim in the criminal justice system, and victims of the abuse of power. The Symposium also represents a networking and information exchange opportunity not to be missed!

International Advocacy and Consulting: The WSV maintains accredited representatives to the Council of Europe, and to United Nations offices in New York, Geneva, Vienna, Nairobi, and at other locations where the UN meets; up to 10 accredited members may represent the Society at each CoE or UN event relevant to victim issues. Any member in good standing may apply to the Executive Committee to be accredited to represent the Society at a specific event, meeting or office.

Advocating for a full UN Convention on Justice and Support for Victims of Crime and Abuse of Power: Ten years after the adoption of the Declaration by the UN General Assembly, several members of the Society were instrumental in the development of two important instruments meant to further the implementation of the Declaration around the globe. These documents, the Guide for Policy Makers, and a Manual on the Implementation of the UN Declaration, provide policy-makers and practitioners with concrete examples of how they can push forward the implementation of the Declaration in their region.

Continuing with this tradition of global advocacy the World Society of Victimology, in partnership with the International Victimology Institute (INTERVICT) of Tilburg University, is currently involved in the development of a full UN Convention for Victims (latest draft).

WSV sponsored workshops, courses and seminars: These are held in many different countries. These have included four international workshops on Victim Rights, on Comprehensive Victim Assistance, on Minorities and Victimology, and on Abuse of Power.

Special two-week Post Graduate Courses in Victimology are held annually in Europe, Japan and South America. Announcements as to date, location and registration will be posted as they are made available

Seelische, emotionale und Verhaltensstörungen (SEV), wie Depressionen und Drogenmissbrauch bei Kindern, Jugendlichen und jungen Erwachsenen, stellen eine enorme Belastung für die Betroffenen, ihre Familien und die Gesellschaft dar. Sie bedrohen die Zukunft, Gesundheit und das Wohlbefinden junger Menschen. Anzeichen für mögliche SEV-Störungen sind oft in einem sehr jungen Alter deutlich.
